Natural stone processing

Natural stone processing is dusty, wet and dangerous. Lack of awareness of Occupational Safety and Health (OSH) often causes work-related diseases, such as silicosis and loss of hearing. Accidents, lack of insurances and employment contracts are some other frequent problems. Furthermore, in some countries, child labour and forced labour still occur.

Public Procurement

Fair Stone offers an independent system to confirm compliance with social and environmental requirements throughout the supply chain. By purchasing and demanding labeled stones you contribute to making globalization a positive experience for everyone.

WiN=WiN Fair Stone

Fair Stone, existing since 2008, is the international social and environmental standard for natural stone imports from developing countries and emerging markets.

Fair Stone Partners implement social and environmental criteria within their supply chains step-by-step and thus improve actively the working conditions.

Fair Stone Process

Local Fair Stone representatives regularly visit the factories and quarries which are registered within the Fair Stone System to control, support and strengthen the implementation process. (Announced & unannounced visits).

Fair Stone suppliers will be certified by an external independent organization (e.g. TÜV Rheinland AG / QS Zürich AG) no later than three years after the registration.

Following minimum criteria must be met in order to use the Fair Stone label:

- No child or forced labor
- Compliance with ILO-Core Labor Conventions
- Occupational Safety and Health (OSH)
- Capacity building for employees
- Product traceability (Tracing Fair Stone)
- Clear material flow
